SCE&G Electronic Bulletin Board Terms and Conditions

South Carolina Electric & Gas Company ("SCE&G") provides this Internet website to facilitate access to its Electronic Bulletin Board ("EBB") and make available information concerning transportation services on SCE&G's system under the following terms and conditions ("Terms and Conditions"). If you do not accept these Terms and Conditions, please do not use the Internet website.

- 1. <u>Internet Website Access</u>. Upon receipt of an effective EBB Access Authorization Form properly executed by a customer or customer's agent/marketer of SCE&G (each, a "User"), SCE&G will provide employees, agents, and other representatives of User specified in an EBB Access Authorization Form (collectively, "Authorized Persons") with user IDs and passwords necessary to access and use the EBB, including submitting nominations pursuant to a Customer Authorization Form. Use of the EBB is subject to SCE&G's South Carolina Public Service Commission approved tariff ("Tariff") and to these Terms and Conditions. Should a conflict exist between the Tariff and these Terms and Conditions, the Tariff shall control. Nominations submitted via the EBB must comply with the procedures outlined in the applicable transportation agreement(s)
- 2. <u>Authorized Persons</u>. Any person permitted by User to access the EBB shall have the legal authority to act on behalf of User in performing those functions and capabilities indicated on the EBB Access Authorization Form for which such person is authorized, including those functions and capabilities that are available presently and those functions and capabilities that will become available at a later date. Upon proper completion and execution of the EBB Access Authorization Form by User, SCE&G may rely on User's representation that all Authorized Persons have been duly authorized by User to perform the capabilities indicated on the EBB Access Authorization Form. User is responsible for providing SCE&G with a revised EBB Access Authorization Form upon any material change to the information on the form.
- User IDs and Passwords. Management of User's online account, including user ID and 3. password management, is entirely User's responsibility. Online account management means User is solely responsible for authorizing access to the EBB through the user ID and password process. During the user ID and password sign-on process, Authorized Persons who are authorized by User to have access must establish their online account identification and accompanying passwords. User and User's Authorized Persons are solely responsible for maintaining the privacy of User's account information. User IDs and passwords are confidential and are used to identify User or an Authorized Person acting on behalf of User. On receipt of a fully completed, properly executed, and effective EBB Access Authorization Form from User, SCE&G will provide an Authorized Person with a user ID and an expiring password, which the Authorized Person must change during the first login to the EBB. Passwords should be at least six (6) characters in length and should contain a combination of non-repetitive alphanumeric and special characters. User is responsible for keeping confidential and causing its Authorized Persons to keep confidential all user IDs and passwords issued by SCE&G for use on the EBB. Any use of the EBB by any person using any of User's user IDs or passwords is deemed to be use by User. User is responsible for and fully liable for any use of the user IDs or passwords issued to User's Authorized Persons and any actions taken on the EBB enabled by such use.

- 4. <u>Inactive User IDs</u>. A user ID that is inactive for 180 days will be suspended automatically. If a user ID is suspended, User may contact SCE&G's Transportation Administration Department or the appropriate SCE&G customer account manager to request that it be reinstated.
- 5. <u>Invalidation of User IDs and Passwords</u>. SCE&G has the right to invalidate user IDs and passwords at any time and SCE&G may terminate access to the EBB for any reason, including, but not limited to, the violation of any of these Terms and Conditions.
- 6. <u>Proper Access</u>. User may attempt to access only data on the EBB for which User has access authorization. User and User's Authorized Persons must not attempt to exceed their authorization.
- 7. <u>Unauthorized Access</u>. If, at any time, User is able to access any information on the EBB for which it is not authorized, User immediately must notify SCE&G's Transportation Administration Department or the appropriate SCE&G customer account manager and User must not disclose or otherwise make available such information to any other person, entity, company, corporation, or third party.
- 8. <u>Security Breach</u>. User immediately must notify SCE&G by telephone or by electronic mail if there is any indication that a security breach has occurred with regard to User's user IDs and passwords, including, but not limited to: (i) loss of confidentiality of user IDs and passwords; (ii) termination of employment of any Authorized Person; or (iii) loss of authority to access the EBB by any Authorized Person.
- 9. <u>Reliance</u>. SCE&G may act, and is protected fully in acting, in reliance on any acts or things done or performed by persons using User's user IDs and passwords (so long as SCE&G has not been notified properly of a security breach as set forth herein), and SCE&G shall be held harmless for any omission or failure by User to act or perform any duty required by a function or capability accessed through the EBB.
- 10. <u>Indemnification</u>. User shall indemnify, save, and hold SCE&G, its subsidiaries or affiliates and their directors, officers, employees, and agents free and harmless from any and all suits, regulatory proceedings, actions, claims (including attorneys' fees and court costs), debts, accounts, damages (including punitive damages), costs, losses, injuries, or expenses arising from or out of adverse claims of any and all persons arising out of any breach of these Terms and Conditions by User or its Authorized Persons, or out of any access or use of the EBB, or the information contained therein by User.
- 11. Warranty Disclaimer. INFORMATION AND FUNCTIONALITY PROVIDED ON THE EBB IS ON AN "AS IS" BASIS WITHOUT ANY WARRANTIES OF ANY KIND. TO THE FULLEST EXTENT PERMITTED BY LAW, SCE&G DISCLAIMS ALL WARRANTIES, INCLUDING THE WARRANTY OF MERCHANTABILITY, NON-INFRINGEMENT OF THIRD PARTY RIGHTS, AND THE WARRANTY OF FITNESS FOR PARTICULAR PURPOSE. ALTHOUGH SCE&G STRIVES TO PROVIDE THOROUGH AND ACCURATE MATERIALS ON THE EBB, NO WARRANTIES ARE MADE ABOUT THE ACCURACY, RELIABILITY, COMPLETENESS, OR TIMELINESS OF ANY MATERIAL, SERVICES, SOFTWARE, TEXT, GRAPHICS, AND LINKS.

- 12. <u>Limitation of Liability</u>. IN NO EVENT SHALL SCE&G, ITS AFFILIATES, OR ANY THIRD PARTIES MENTIONED ON THE EBB BE LIABLE FOR ANY DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, LOST PROFITS, OR DAMAGES RESULTING FROM LOST DATA OR BUSINESS INTERRUPTION) RESULTING FROM THE USE OR INABILITY TO USE THE EBB, WHETHER BASED ON WARRANTY, CONTRACT, TORT, OR ANY OTHER LEGAL THEORY, AND WHETHER OR NOT SCE&G OR ANY OF ITS AFFILIATES IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 13. <u>Modification or Termination</u>. SCE&G may modify these Terms and Conditions by posting notice of such modification on the EBB. SCE&G reserves the right to modify or terminate the EBB at any time.
- 14. <u>Dispatching Notices</u>. To the extent User uses the EBB to transmit and receive dispatching notices under SCE&G's Tariff, then such provisions are deemed to be satisfied and notice through the EBB will constitute valid notice between the parties.
- 15. Governing Law. The parties hereto agree that interpretation and performance of these Terms and Conditions are governed by the laws of the State of South Carolina without recourse to South Carolina law governing conflict of laws. Any action arising out of the Terms and Conditions must be filed and resolved exclusively in a court or tribunal sitting in Lexington County, South Carolina. These Terms and Conditions and the obligations of the parties are subject to all present and future valid laws, state and federal, with respect to the subject matter, and to all valid present and future orders, rules, and regulations of duly constituted authority having jurisdiction.
- 16. <u>Electronic Signatures</u>. User agrees that, whenever the EBB provides the option of electronic execution of agreements, clicking on the designated button or region of a web page constitutes the signature of the Authorized Person to execute the agreement.
